

AICPA Outstanding CPA in Government Awards

Outstanding CPA in Government Impact Award

The Outstanding CPA in Government Impact Award recognizes the impact of significant contributions of the CPA to the efficiency, effectiveness or innovative service delivery of their respective local state or federal employer organization. Current or recent accomplishments (3-5 years) are the focus of this award.

Outstanding CPA in Government Career Contribution Award

The Outstanding CPA in Government Career Contribution Award recognizes the significant contributions to the CPA profession via government service at the local, state or federal level over a candidate's entire career. Career Contribution Award candidates will have demonstrated exceptional leadership and high ethical standards and a track record of professional excellence.

The award will be presented in August during the AICPA's National Governmental Accounting and Auditing Conference (GAAC) on August 15, 2022.

Self-nominations are not accepted. All nominations must be received by April 30th, 2022.

Nominee eligibility

- Nominee must be a member of the AICPA and/or a State CPA Society.
- Nominee must not be the current president of his/her State CPA Society.
- Nominee must not be a member of the AICPA Board of Directors.
- Nominee must not be a member of the Government Performance and Accountability Committee.

Selection process

- Nominations will be accepted based upon fulfillment of the requirements by the Awards Subcommittee of the AICPA Government Performance and Accountability Committee.
- Complete nomination packages will be approved for completion by the Awards Subcommittee and forwarded to an independent panel of judges
- The winners will be selected by an independent panel. The panel will be composed of three distinguished individuals from each level of government who are knowledgeable of the accounting profession.
- Individual members of the AICPA Government Performance and Accountability Committee and employees of the AICPA are not permitted to nominate a candidate.

Please note: Letters of Recommendation must contain all the following criteria:

- 1. Please describe the significant accomplishments that best characterize the nominee's contribution to the CPA profession during the span of their career in government service.
- 2. Nominee's contributions to state <u>and/or</u> national professional organizations, and the impact of those contributions.
- 3. Nominee's demonstrated leadership and service to the profession outside of the related government organization.
